1. Conditions of hire - Responsibilities of the person hiring the trailer (the "hirer")

The hirer agrees to indemnify Southern Trailers Limited for any & all loss and damage to the trailer while on hire during which time the hirer is solely responsible for the trailer and this responsibility CANNOT be delegated to any third party. The hirer will at no time or in any respect hold Southern Trailers Limited responsible for any personal injury or damage to their property or the property of anyone else whilst using the trailer. It is the responsibility of the person hiring the trailer to ensure that they and anyone else towing the trailer has the correct driving licence for the vehicle and trailer they are using.

The hirer must ensure the towing vehicle is suitable for the trailer being hired.

It is the hirer's responsibility to establish whether a Tachograph is required.

2. Responsibility for lost, stolen or damaged trailers

The hirer agrees to pay Southern Trailers Limited the full replacement cost, whilst in their charge, of any trailer lost, stolen or damaged beyond economical repair. Southern Trailers Limited's costs will also include any potential loss of hire charges during any period of consequential repair or replacement.

3. Return of hired trailers

A days hire is between **8.30am to 5.00pm on said day** and our trading hours are Mon - Fri 8am -5pm and 8am to 12.30pm Saturday. Trailers must be returned during our working hours; they must not be left until fully inspected by a member of our staff, until which time the hirer is fully responsible for the trailer. In the event a trailer is left uninspected the hirer is liable to forfeit their full deposit at the sole discretion of Southern Trailers Limited.

4. The trailer and goods are not insured by Southern Trailers Limited whilst in your possession.

During the period of hire, trailers will be used completely at the hirer's own risk. This includes all moving parts: winches, cables, hooks, rack and pinion etc. and any goods, irrespective of ownership, carried on the trailer. A refundable cash deposit of £100 for trailer use within the UK and £250 for continental use is required before the start of the hire period. It is the hirers responsibility to secure any load being carried and provide the means to do this.

It is in your own interests to examine trailers carefully before leaving our premises, and to arrange insurance cover on the basis of the foregoing ~ we have no choice but to recover the full costs of any damage incurred (including punctures) while on hire to you.
